SUMMARY ANNUAL REPORT

FOR BATES COLLEGE 403(b) Retirement Plan

This is a summary of the annual report for the Bates College 403(b) Retirement Plan, EIN 010211781, Plan No. 002, for the period January 1, 2014 through December 31, 2014. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by annuity contracts issued by Teachers Insurance and Annuity Association and College Retirement Equities Fund. Plan expenses were \$3,219,582 in benefits paid to participants. A total of 1,595 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$70,640,622 as of December 31, 2014 compared to \$64,624,998 as of January 1, 2014. During the plan year the plan experienced an increase in its net assets of \$6,015,624. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year. The plan had total income of \$9,250,194 including employer contributions of \$4,430,883 rollover contributions of \$574,839 and earnings from investments of \$4,244,472.

The total premiums paid for allocated contracts issued by TIAA for the plan year ending December 31, 2014 were \$643,035.

Minimum Funding Standards

Enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
