# For Bates College 403(b) Retirement Plan

This is a summary of the annual report for Bates College 403(b) Retirement Plan, EIN 01-0211781, Plan No. 002, for period January 01, 2018 through December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$5,808,803. These expenses included \$59,676 in administrative expenses, and \$5,749,127 in benefits paid to participants and beneficiaries. A total of 1,758 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$92,896,791 as of December 31, 2018, compared to \$95,187,738 as of January 01, 2018. During the plan year the plan experienced a decrease in its net assets of \$2,290,947. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$3,517,856, including employer contributions of \$1,203,616, employee contributions of \$4,142,629, other contributions of \$1,502,713, earnings from investments of (\$3,428,739), and other income of \$97,637.
