Individual Interdisciplinary Major

Students may propose an individual interdisciplinary major. This involves a detailed program of study with courses drawn from at least two department(s) and/or program(s), but only one senior thesis and/or comprehensive examination.

Liberal Arts-Engineering Dual Degree Program

After three years of full-time study at Bates, qualified students may enroll in a two-year engineering program at Columbia University, Dartmouth College, Rensselaer Polytechnic Institute, Case Western Reserve University, or Washington University. Students earn both an undergraduate degree in engineering from Bates and a Bachelor of Science from the engineering-school affiliate.

Academic Community-Engaged Learning

In 2021-2022, 16 academic courses from diverse departments and programs included significant community-engaged academic work, and 21 senior theses were community-engaged. 606 Bates students produced 18,520 hours of academic community-engaged work. Five students participated in the Community-Engaged Research Fellows program, and 12 students completed an action/research project, representing several academic disciplines. Well over half of all students engage in community-engaged academic work during their time at Bates, whether through taking one or more community-engaged learning courses or completing a community-engaged thesis or capstone project.

Community Volunteerism and Student Leadership Development

Twenty-nine students participated in the Bonner Leader Program, devoting four-to-six hours per week working in the community and another two hours per week engaged in training and reflection activities. In 2021-2022, 4,432 documented hours of volunteer work were contributed by Bates students through residence life programs, student clubs and athletic teams, civic engagement leadership programs, and individual volunteer commitments.

The Bates–Morse Mountain Conservation Area: 2022 Season

More than 23,550 people visited the area during the 2022 gate-keeping season which totaled 194 gatekeeping days. A total of 757 individuals visited BMMCA for educational purposes in 2022, including participants of the Maine Chapter of the Fulbright Association (October 2022), Bates Alum Service Day (April 2022), and Reunion Walk (June 2022). Seven Bates students conducted independent research in BMMCA and Phippsburg. This area is home to two endangered bird species.

Bates College Museum of Art: 2022 Fiscal Year

Since September 2022, the Museum of Art has organized and mounted four exhibitions and welcomed 1,146 visitors, 81% of whom attended an educational program or event. Of those, 732 were students or faculty, and 197 were from off-campus. The museum supervised 103 career-oriented, for-credit and paid intern work sessions for 14 interns, 37 curricular tours of exhibitions and collection viewings, 14 community tours by community groups local K-12 schools, and two lectures. The museum also organized 20 weekly life drawing sessions and partnered with student clubs and the Multifaith Chaplaincy office to offer 4 art-making events related to its collections of relief prints, collages, and other holdings.
